## **Resolution Supporting the Expansion of Voting Rights**

**WHEREAS**, President Lyndon B. Johnson signed the Voting Rights Act into law in August 1965, taking significant steps to expand access to the ballot box for all Americans; and

**WHEREAS**, since 2011, the Voting Rights Act and the protections granted thereunder have been threatened by the rulings of the United States Supreme Court and the actions of GOP-led state legislatures and Secretaries of State; and

**WHEREAS**, over 40 states, including Florida, Ohio, Texas, North Carolina, Arizona, Kansas, and Wisconsin, have enacted voting restrictions such as the elimination of same-day registration, reduction of early voting periods, making voter registration more difficult, and the implementation of photo identification laws; and

**WHEREAS**, voting restrictions disproportionally hurt women, minority communities, working people, seniors, and young people; and

**WHEREAS**, in April, President Obama said, "The right to vote is threatened today in a way that it has not been since the Voting Rights Act became law nearly five decades ago."

WHEREAS, Democrats have a long and proud history of protecting and expanding voting rights and recognize our country is better off when more people participate in our electoral process; and

**WHEREAS,** Democrats embrace the recommendations of the Presidential Commission on Election Administration and believe that technology and best practices can improve elections, while GOP elected officials, party leaders and political consultants have expressed that their party's best path to victory is if fewer people vote.

**WHEREAS,** in February, the DNC announced the creation of the Voter Expansion Project to ensure that every eligible voter is registered, every registered voter is able to vote, and that every vote is accurately counted; and

**WHEREAS**, the Voter Expansion Project supports every state in protecting and expanding voting rights by (i) engaging our 100,000 members, 3,000 grassroots advocates, hundreds of alumni staff, and 30,000 attorney volunteers, (ii) empowering states to build voter expansion programs using the Voter Expansion Toolkit and resources, and (iii) building tools and reports for our voter expansion programs to use in pursuit of their voter registration, election administration, volunteer management, and election day goals; and

**WHEREAS,** in June the DNC launched IWillVote.com, a comprehensive voter education and registration site for all 50 states and the District of Columbia, designed to make voting easier and more convenient for a citizen to participate in the electoral process when he or she understands when to vote, where to vote, what to bring with them to vote, and what to expect on Election Day in order to vote; and

WHEREAS, there is always more work to be done to ensure the right to vote;

**THEREFORE BE IT RESOLVED** that the DNC will continue to support President Obama and all Democrats in their efforts to protect and expand voting rights for all.

#### **Resolution Honoring Women's Equality Day**

**WHEREAS,** in July 1848, Elizabeth Cady Stanton and Lucretia Mott organized the first women's rights convention in American history, more than 300 women and men met in Seneca Falls, NY to protest the mistreatment of women in social, economic and religious life; and

**WHEREAS**, the Declaration of Sentiments and Resolutions issued at this convention detailed the "injuries and usurpations" that men had inflicted upon women and demanded that women be granted all of the rights and privileges men held, including the right to vote; and

**WHEREAS,** a women's suffrage amendment was first introduced in Congress on January 10, 1878 and was resubmitted numerous times until June 4, 1919, when the 19<sup>th</sup> Amendment to the U.S. Constitution, which guarantees women the right to vote, was passed by Congress and on August 18, 1920 was ratified by the required 36 states; and

**WHEREAS,** 50 years later, on August 26, 1970, Betty Friedan and the National Organization for Women organized a nationwide Women's Strike for Equality, where women across the country demanded equal opportunities in employment, education and 24-hour child-care centers; and

**WHEREAS**, in 1971, Congresswoman Bella Abzug (D-NY) introduced a bill designating August 26<sup>th</sup> as Women's Equality Day, to commemorate the contributions, sacrifices, and strides that women have made in our society; and

**WHEREAS**, Women's Equality Day highlights the enormous progress women have made as well as the work that still needs to be done in order to achieve true equality; and

**WHEREAS,** Republicans in Congress continue to push for more restrictions on women's health care and oppose policies that would bring the country closer to pay equity, and Republicans are working across the nation to restrict the accessibility of voting, which make it more difficult for women and other Americans to cast their ballot; and

WHEREAS, Democrats support equal pay, access to affordable health care, and expanded opportunity; and

**THEREFORE BE IT RESOLVED**, that the Democratic Party recognizes Women's Equality Day and the important role that women play to our party and country.

**WHEREAS**, under President Obama's leadership and because of the Supreme Court's monumental decision to strike down the Defense of Marriage Act, our country has made enormous steps toward equality in the past six years; and

**WHEREAS**, the Affordable Care Act made it illegal for health insurers to deny coverage to people based on sexual orientation or gender identity. And next year because of President Obama's signature legislation, health insurance companies that offer coverage to straight couples, will offer coverage plans for all couples; and

**WHEREAS**, the Obama Administration implemented hospital visitation rights for LGBT couples; and

**WHEREAS,** in June 2014, the White House hosted the first-ever Global Lesbian, Gay, Bisexual, and Transgender (LGBT) Human Rights Forum to make sure the United States is part of a greater discussion to protect the rights of the LGBT community around the world;

**THEREFORE BE IT RESOLVED** that the DNC will continue to support President Obama and all Democrats in their efforts to protect and expand the rights of the LGBT community.

Resolution Commemorating the 50<sup>th</sup> Anniversary of Freedom Summer and Honoring the Victims

**WHEREAS**, fifty years ago a campaign known as the Freedom Summer of 1964, a grassroots movement to register eligible citizens to vote in Mississippi, occurred; and

**WHEREAS,** Freedom Summer was initiated by the Council of Federated Organizations (COFO), a coalition of the Mississippi branches of the four major civil rights organizations, SNCC, CORE, NAACP and SCLC, and thousands of brave citizens of all ages from Mississippi and across the country who sought to propel justice forward in an area of the country that had denied voting rights to minorities for over a century; and

WHEREAS, volunteers and activists spread out across Mississippi into black communities and churches and set up workshops on registering to vote and nearly forty Freedom Schools designed

to provide a progressive curriculum to prepare students to become political actors in their communities; and

**WHEREAS,** more than one thousand black and white volunteers were arrested and at least eighty were beaten either by mobs or the police forces in Mississippi; and

**WHEREAS**, three youth in the movement, a black Mississippian activist named James Chaney and two white volunteers from New York named Andrew Goodman and Michael Schwerner, tragically were murdered near Philadelphia, Mississippi, for their efforts to bring equal voting to all areas of the state; and

**WHEREAS,** the movement contributed to the breakdown of the isolation and repression of the South by bringing much needed national media attention to the persecution of black voters and those seeking to register new voters; and

**WHEREAS,** the tragedy and actions of the Freedom Summer mobilized many in Congress to pass the Civil Rights Act of 1964 and provided momentum for the Voting Rights Act of 1965; and

**WHEREAS,** this summer and its struggles helped highlight civil rights issues and implant them into the national conscious, thus serving as a source of inspiration, of pride, of determination for Americans yearning for equality; and

**WHEREAS,** every current and future generation of the United States should remember the lessons of Freedom Summer—to keep and treasure the right to vote and work to extend, never restrict, the franchise to every citizen of this country;

**WHEREAS,** the American people will soon be able to commemorate the history of the Freedom Summer and other achievements at the Smithsonian National Museum of African American History and Culture on the National Mall in 2016; and

**WHEREAS**, historian Doug McAdam said of the impacts of the Freedom Summer: "historical currents do not irresistibly propel themselves and everyone in their path. No matter what their broader structural or ideological roots, they both carry along and are carried along by people, who are not merely passengers of history, but pilots as well;"

**THEREFORE BE IT RESOLVED** that the Democratic National Committee commemorate the 50<sup>th</sup> anniversary of Freedom Summer for its contributions to our country and offer its condolences to the families of the victims that passed that summer.

# Resolution to Urge Congress to Provide the Residents of the District of Columbia with Statehood and Full Democracy

**WHEREAS**, the U.S. Constitution that was ratified in 1788, provided the right to vote for representation in Congress to the "People living" in the several states of the United States, and included citizens of the several States as well as those living on the land that would later be designated by the federal government for the nation's capital as ceded by Maryland and Virginia to become the District of Columbia; however, through the enactment of the "District of Columbia Organic Act of 1801" DC residents were disenfranchised from voting for representative Members of Congress for 213 years; and

**WHEREAS**, DC residents pay among the highest per capita federal taxes in the nation and more than 200,000 residents have served in the federal Armed Forces, and yet DC residents have no vote in the US Congress; and

**WHEREAS**, the residents of the District of Columbia lack full democracy, equality, and citizenship enjoyed by the residents of the 50 states; and

WHEREAS, the Democratic National Committee passed the "Resolution in Support of the District of Columbia Fair and Equal Voting Rights Act" in 2007, the "Resolution in Support of the District of Columbia House Voting Rights" in 2009, and the "Resolution to Urge Congress to Provide the Residents of the District of Columbia with Full Democracy" in 2011; and the Black Caucus, Ethnic Coordinating Council, LGBT Caucus, Veterans and Military Families Council, Women's Caucus and others adopted resolutions in support of statehood at the DNC 2014 Winter Meeting; and,

**WHEREAS**, the new House majority began the 113th Congress by continuing to deny DC Delegate Eleanor Holmes Norton a vote in the Committee of the Whole, and trampling on DC Home Rule by introducing riders on how DC spends its locally raised tax dollars; and

**WHEREAS**, in January 2013 DC Delegate Norton introduced three bills on statehood and voting representation for the District of Columbia: HR 292, the New Columbia Admission Act providing for statehood, HR 362, the DC Equal Representation Act of 2013 allowing DC representation in both the House and Senate, and HR 363, the DC House Voting Rights Act of 2013 providing DC with a House vote; and

**WHEREAS**, in January 2013 DC Delegate Norton also introduced HR 345, the DC Budget Autonomy Act of 2013 to allow the DC budget of local taxpayer-raised funds to become law passed a balanced budget for each of the last 18 years, the District of Columbia has faced the possibility of being shut-down each year because of Congressional deliberations over the federal budget and the imposition of riders opposed by the District of Columbia; and in January 2014 introduced HR 3816, the DC Paperwork Reduction Act that would allow DC local legislation to take effect without a Congressional review period; and

**WHEREAS**, the residents of the District of Columbia have endorsed statehood for the District of Columbia, and passed a District-wide referendum on budget autonomy; and

**WHEREAS**, President Barack Obama is in support of statehood for the nation's capital, and has previously spoken in favor of giving the District voting representation in Congress and full control of its budget and laws; and

**WHEREAS**, it has been 50 years since the passage of the Civil Rights Act and 40 years since the District of Columbia was granted Home Rule, and the residents of the District of Columbia have yet to have the same rights as the residents of the 50 states;

**THEREFORE BE IT RESOLVED** that the Democratic National Committee endorse and encourage citizens and their members of Congress to support statehood and full democracy for the District of Columbia that will guarantee to the residents of the District of Columbia full Congressional voting representation, budget autonomy, and all of the rights that the people of the 50 United States enjoy.

#### Resolution Supporting Closing the Racial Wealth Gap

**WHEREAS**, communities of color, including African Americans, Hispanics, Native Americans and Asian American and Pacific Islanders, among whom are firsts generation higher education students, face a wealth gap in the United States due to systemic and social barriers that limit economic mobility, according to the Center for Global Policy Solutions; and

**WHEREAS**, the median wealth for White households is 16 times that of African American households and 14 times that of Hispanic households; and

**WHEREAS,** the unemployment rate for African Americans is 11 percent, 7.3 percent for Hispanics, 11.3 percent for Native Americans, and 5.2 percent for Whites, compared with a national rate of 6.2 percent; and

**WHEREAS,** homeownership is a key factor in building wealth over generations, but African American and Hispanic communities have a homeownership rate that is over 25 percent lower that of White families; and

**WHEREAS**, even after the housing crash, 68 percent of Whites are homeowners compared to 42 percent of African Americans, 43 percent of Hispanics, and 59 percent of Asians; and

**WHEREAS**, 41.5 percent of African-Americans, 30.9 percent of Hispanics, 11.5 percent of Asian-Americans, and 17.8 percent of Whites got higher-priced mortgages immediate preceding the housing crisis; and

**WHEREAS,** African Americans, Latinos and Asian Americans lost 53, 65, and 54 percent of their wealth, respectively, from 2005-2009, compared to a 16 percent loss for whites; and

**WHEREAS,** African Americans and Latinos have a liquid wealth of \$200 and \$340, respectively, compared to \$23,000 for whites; and

**WHEREAS,** 63.8 percent of African-Americans, 54.4 percent of Hispanics, 57.1 percent of American Indian/Alaskan Native, 51.9 percent of Hawaiian/Pacific Islander, and 37.6 of Whites report ever using alternative financial institutions, compared to a 42.9 percent national average; and

**WHEREAS**, alternative financial institutions charge excessive fees per service, including an average of 64 cents per money order and 86 cents per transaction; and

**WHEREAS**, workers of color are more likely to work in service sector jobs (25.6 percent of African Americans, 26.6 percent of Hispanics, and 16.8 percent of Whites) than the management sector (28.7 percent of African Americans, 20.2 percent of Hispanics, and 38.8 percent of Whites), which pay mean annual wages of \$24,710 compared to management sector jobs which pay \$110,550.

**WHEREAS**, 42.1 percent of White students enroll in college, compared with 36.4 percent of African American students, 37.5 percent of Hispanic students, and 27.8 percent of Native American students, all of which also graduate at lower rates; and

**WHEREAS,** increasing the educational attainment among communities of color by ensuring equitable education quality in public schools can contribute to higher rates of postsecondary education and financial literacy; and

WHEREAS, 62 percent of White households invest in high-return assets, including stocks, business assets, and real estate, only 36 percent of African Americans and 30 percent of Hispanics do so; and

**WHEREAS,** bringing communities of color into the mainstream financial system and establishing universal savings accounts with a match component can allow families to invest in assets would help close the wealth gap; and

WHEREAS, strengthening Social Security can help bridge the racial wealth gap; and

**WHEREAS**, economic inequality contributes to social instability and undermines our economy and democratic institutions;

**THEREFORE BE IT RESOLVED** that the Democratic Nation Committee applauds the work documenting the scope of the existing racial wealth gaps and supports targeted efforts to close the gap for communities of color.

## **Resolution on Financial Treatment of Overseas Americans**

**WHEREAS,** the Foreign Account Tax Compliance Act (FATCA) was adopted by Congress in 2010 to identify and apprehend US taxpayers illegally avoiding paying taxes in the United States by moving untaxed earnings and assets into offshore accounts; and

**WHEREAS**, ensuring that every US taxpayer pays her or his fair share is a laudable goal and part of the necessary price of liberty; and

**WHEREAS,** FATCA obliges non-US financial institutions to disclose the accounts and account balances of American citizens to the US government—even when there is under \$100 in the account; and

**WHEREAS**, the FATCA legislation has the unintended consequence of treating the many millions of honest Americans living outside the US who are not trying to hide from taxation on a par with tax evaders; and

**WHEREAS,** the overwhelming majority of Americans living abroad have the same sorts of jobs as their friends and families in the US and pay taxes on their earnings in their countries of residence; and

**WHEREAS,** non-US financial institutions are closing the accounts of Americans to try to avoid the cost of compliance and the hefty penalties they face if they do not comply—including the withholding of 30% on certain payments to the banks; and

**WHEREAS**, Americans abroad should be entitled to normal banking and financial services in the countries in which they live, just as they are when they return home to the US; and

**WHEREAS**, there are proposals that would have the effect of treating Americans with financial accounts in the foreign countries in which they are legally resident the same as Americans living in the US with financial accounts in the US. In particular, financial institutions in a foreign country should be relieved from reporting on the accounts of Americans who are legally resident in that country; and

**WHEREAS**, the Democratic Party wholeheartedly supports efforts to apprehend US taxpayers and corporations who make use of illicit schemes, structures, accounts and facilities to move untaxed earnings out of the US in order to avoid taxation; and

**WHEREAS**, the Republican National Committee has passed a resolution calling for the repeal of FATCA, thereby demonstrating their support for those who avoid paying their fair share of taxes—even when they do so by illegal and illegitimate means; and

**WHEREAS**, the IRS has well-established guidelines for determining that an American is a bona fide resident of a foreign country;

**THEREFORE BE IT RESOLVED** that the Democratic National Committee (DNC) support the continued application of FATCA as it applies to offshore accounts held by US taxpayers resident in the US; and

**WHEREAS,** Garcia became the executive director of Annie's List in February of 2013, where she spearheaded a year in which female candidates and reproductive rights have had unprecedented visibility, raising money to support pro-choice candidates; and

**WHEREAS,** Senator Wendy Davis said of Garcia, "Where others saw challenges, Grace saw possibilities and was always inspiring others to believe in her vision. ... Her absence in the landscape of Texas politics and what she meant to us personally will leave a void that simply cannot be filled. Grace did so much for me and for countless Texas women. She was a part of this extraordinary journey we've been working on together that wouldn't have been possible without her;"

**WHEREAS**, in 1983, he was named a fellow at the Institute of Politics at Harvard University's Kennedy School of Government and he also served in advisory roles for Walter Mondale's presidential campaign, specifically on Central American issues; and

WHEREAS, on the 10<sup>th</sup> of May 2014, Patrick Lucey passed away;

**WHEREAS,** upon learning of Frank's death, President Obama said, "Billy never stopped fighting make sure future generations would be able to enjoy the outdoors as he did, and his passion on the issue of climate change should serve as an inspiration to us all;"

WHEREAS, Maya Angelou was born April 4, 1928, in St. Louis, Missouri; and

WHEREAS, between 1928 and 1942, she grew up both in St. Louis and Stamps, Arkansas; and

**WHEREAS,** in 1941 Angelou attended George Washington High School and studied drama and dance on scholarship at the California Labor School; and

**WHEREAS,** throughout the 1950's she cultivated her artistic skills by touring in a production of "Porgy and Bess," recording an album entitled *Calypso Lady*, and joining the Harlem Writers Guild, among many other endeavors; and

**WHEREAS,** in 1969 Angelou published her autobiography, "I Know Why the Caged Bird Sings," nominated for a National Book Award; and

**WHEREAS,** on January 20, 1993 she recited her poem "On the Pulse of Morning" at President Clinton's inauguration, becoming the second poet, and first African American and woman poet to read at a presidential inauguration; and

**WHEREAS,** Angelou has been awarded numerous accolades for her artistic excellence and social justice efforts including a Pulitzer Prize nomination (1972), Langston Hughes Medal (1991), NAACP Image Award (1997), induction into the National Women's Hall of Fame (1998), Voice of Peace Award (2008), and multiple Grammy Awards (1993, 1995, 2002); and

**WHEREAS**, as a poet, dancer, actor, producer, teacher, and activist she has served as a role model for the American people, illuminating thoughts on civil rights, justice, and compassion; and

**WHEREAS**, on May 28, 2014, Maya Angelou passed away at her home in Winston-Salem, North Carolina; and

**WHEREAS,** President Obama described her as "a brilliant writer, a fierce friend and a truly phenomenal woman" and "one of the brightest lights of our time,"

Resolution Commemorating the Life and Legacy of Ruby Dee

**WHEREAS,** Ruby Dee was born in Cleveland, Ohio, on October 27, 1922, and moved to New York's Harlem as a child; and

**WHEREAS**, at the age of 11, she attended her first protests as a child joining the picket lines to rally against discriminatory hiring practices; and

**WHEREAS,** Dee graduated from highly competitive Hunter High School in 1939 and attended Hunter College graduating in 1945 with a degree in romance languages; and

**WHEREAS**, she joined the American Negro Theatre in 1941 which kick started her acting career; and

**WHEREAS,** Dee was a prominent civil rights activists speaking out against many causes such as the treatment of African Americans, the apartheid in South Africa, the Vietnam War, and the execution of Julius and Ethel Rosenberg; and

**WHEREAS,** she and her husband, Ossie Davis, were master and mistress of ceremonies at the 1963 March on Washington and emceed the event; and

**WHEREAS,** in 1965, Dee became the first black actress to perform lead roles at the American Shakespeare Festival in Stratford, Conn.; and

**WHEREAS,** she was a member of the Congress of Racial Equality, the NAACP, the Student Nonviolent Coordinating Committee, Delta Sigma Theta, and the Southern Christian Leadership Conference; and

WHEREAS, Dee and her husband were inducted into the NAACP Hall of Fame in 1989; and

**WHEREAS,** her long and successful career included appearing in the 1950's *The Jackie Robinson Story*, 1961's *A Raisin in the Sun*, 1988's *Do the Right Thing*, and the 2007's *American Gangster*; and

WHEREAS, Dee received various awards and recognition for her work in activism and acting including an Emmy, a Grammy, a Screen Actors Guild award, an Obie, a Drama Desk, the NAACP Image Award, the Kennedy Center Honors, the National Medal of the Arts, the National Civil Rights Museum's Lifetime Achievement Award, the Frederick Douglass Award, the Lifetime Achievement Award from the Screen Actors Guild, and an Oscar nomination; and

WHEREAS, on June 11, 2014, Ruby Dee passed away at her home in New Rochelle, New York; and

**WHEREAS**, Rev. Al Sharpton said, "Ruby Dee was a phenomenally rare artist and a jewel to our nation and community. I was privileged to work on several civil rights cases with her and her husband Ossie Davis. She was as committed to social justice as she was to the screen and stage. She will be greatly missed;" and

**WHEREAS**, President Obama praised the late actress and civil rights activist, saying Ruby Dee "paved the way for generations of black actors and actresses, and inspired African-American women across the nation;"

**THEREFORE BE IT RESOLVED** that the Democratic National Committee honor Ruby Dee for her contributions and inspiration to our country and offer its condolences to her family.

**WHEREAS,** Lynch was the CBS senior political editor from 1985-2005 and a member of the CBC News/New York Times polling consortium; and

**WHEREAS**, she joined American University in 2006 where she taught a class on Politics, Polling and the Youth Vote during the 2008 general election; and

WHEREAS, on August 10, 2014, Dotty Lynch passed away from complications of melanoma;

### **Resolution Promoting Community Policing and Justice for All**

**Whereas,** our hearts go out to the family and other loved ones of Michael Brown and the people of Ferguson who are grieving in the tumultuous aftermath of his death and stand with President Obama in affirming that "we must make sure that the cause of justice & fair administration of law is brought to bear in Ferguson;" and

**Whereas,** our first priority as Americans is a peaceful resolution in Ferguson, Missouri that has continued and as President Obama said, "We are united in common values, and that includes belief in equality under the law; a basic respect for public order and the right to peaceful public protest; a reverence for the dignity of every single man, woman and child among us; and the need for accountability when it comes to our government;" and

**Whereas,** nationally we are challenged to rigorously advance policies that reflect our American values: treating each individual as worthy of dignity and respect; accorded liberty and justice for all; and

**Whereas,** we entrust our police and local law enforcement officers in all states with authority and responsibility to protect and serve us. We appreciate the overwhelming majority of police officers who serve with honor and integrity, putting their lives on the line every day; and

**Whereas,** across America, we promote community policing where peace officers engage in outreach to the neighborhoods, visit elementary schools, youth groups, and local businesses, work with various constituency organizations including communities of color, women, LGBTQ, and people with disabilities to keep people safe and recruit from their ranks, and

**Whereas,** a national shift in post-9/11 policing toward militarization ostensibly to fight armed drug cartels and terrorists attacks has usurped many common sense community policing practices. Indeed many veterans have noted with concern that local police forces wear more military equipment and body armor in American communities than servicemembers do when fighting in war zones overseas. The danger of this militarization is that such an approach presupposes criminality not community, breaks the bonds of trust between police and civilians, and intimidates local residents trying to peacefully exercise their First Amendment rights; and,

**Whereas,** militarized policing in any of our communities is a sign of ineffective policing, because it alienates communities, takes officers off the street and puts them in heavily armed vehicles, and destroys the public trust that is necessary for people to feel comfortable coming forward and calling upon officers for protection; and

**Whereas,** across America, racial profiling and stop and frisk policies alienate people in targeted communities - particularly our youth of color whose only substantive encounter with a law enforcement officer is to be pulled over for driving while brown or stopped and frisked for walking while black. This alienation is unacceptable; moreover, the policies are ineffective. California statistics on convictions following racial profiling-driven detentions and contraband actually found in racial profiling-driven searches were so minuscule that the state agreed to end the practice - and calls for the federal government to do the same are growing; and

**Whereas,** we know that long-term and nationally, public policy, readily available technology and commonsense training can be used to transform justice if we are willing to hire diverse police and civilian leadership, ban racial profiling and stop and frisk practices that disproportionately and adversely impact communities of color, and promote community policing to keep us safe and free.

**Therefore Be it resolved** that the Democratic National Committee stands with our fellow Americans in supports the independent federal investigation by the Department of Justice of the fatal shooting of Michael Brown and the right of the residents of Ferguson to peacefully demonstrate their concerns about this tragedy; and

**Be it further resolved** that the DNC believes it is necessary for a national examination of the state of policing across America and will promote a shift from militarized policing to community policing and justice for all including pursuit of (a) review of the DOD section 1033 program to examine the overall federal effort of giving military-type equipment to local police departments with oversight and appropriate scale of funding so that excessive force does not lead to excessive use of force (b) an end to racial profiling and a retraining of officers to profile criminal behaviors not personal characteristics including race, national origin, sexual orientation or identity or religion (c) maximum use of technology such as wearable body cameras and dashboard cameras to protect the rights of police and civilians, and rigorous standards on the collection storage and transparency of the data collected by such technology (d) retraining officers with a federal excessive force standard and (e) national guidelines for independent investigations of officer-involved shootings;

**Be it further resolved** that the DNC commits to long-term organizing, voting and empowering communities so that if leaders don't change we work together to change course, promote safety, and deliver on the promise of liberty and justice for all.
